No Airboats are permitted to be parked at lot and cannot be tethered to docks on waterfront lots. No weapons or firearms are permitted inside RRRVR buildings/areas including, but not limited to Pools, Rental Event Buildings, gaming courts (i.e. pickleball courts). No trailers on Lots. Boats 24 ft or smaller permitted to be tied to designated dock assigned to renter if staying in Phase 5.
